A BILL FOR AN ACT

To propose an amendment to section 2(d) of article IX of the Constitution of the Federated States of Micronesia to provide that a state may add a surtax upon taxes, duties, and tariffs imposed by the National Government on imports, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Proposed amendment. It is hereby proposed 1 that section 2 of article IX of the Constitution of the 3 Federated States of Micronesia be amended to read as 4 follows: "Section 2. The following powers are express 5 delegated to Congress: 6 (a) to provide for the national defense; 7 to ratify treaties; 8 to regulate immigration, emigration, (c) 9 naturalization, and citizenship; 10 to impose taxes, duties, and tariffs based on 11 (d) imports; provided that a state, at its option, may add a 12 surtax thereon: 13 (e) to impose taxes on income; 14 to issue and regulate currency; 15 to regulate banking, foreign and interstate 16 commerce, insurance, the issuance and use of commercial 17 paper and securities, bankruptcy and insolvency, and 18 patents and copyrights; 19 (h) to regulate navigation and shipping except 20 within lagoons, lakes, and rivers; 21 to establish usury limits on major loans; (i) 22 to provide for a national postal system; 23 (j) to acquire and govern new territory; 24 (k) to govern the area set aside as the national 25 (1)

2	(m) to regulate the ownership, exploration, and
3	exploitation of natural resources within the marine
4	space of the Federated States of Micronesia beyond 12
5	miles from island baselines;
6	(n) to establish and regulate a national public
7	service system;
8	(o) to impeach and remove the President, Vice-
9	President, and justices of the Supreme Court;
10	(p) to define national crimes and prescribe
11	penalties, having due regard for local custom and
12	tradition;
13	(q) to override a Presidential veto by not less
14	than a $3/4$ vote of all the state delegations, each
15	delegation casting one; vote; and
16	(r) to promote education and health by setting
17	minimum standards, coordinating state activities
18	relating to foreign assistance, providing training and
19	assistance to the states and providing support for post-
20	secondary educational programs and projects."
21	Section 2. Procedure. This act shall become effective
22	upon its passage by Congress as an act of the Congress of
23	the Federated States of Micronesia, and it shall be
24	transmitted to the President for action in accordance with
25	chapter 7 of title 1 of the Code of the Federated States of

2 the Constitution following completion of the procedures, 3 including its ratification by the people, as required by the 4 Constitution and law. Section 3. Effective date. This act shall become law 6 upon approval by the President of the Federated States of 7 Micronesia or upon its becoming law without such approval. Date: $\frac{5/16/97}{1}$ Introduced by:
