A BILL FOR AN ACT

To further amend title 9 of the Code of the Federated States of Micronesia, as amended, by further amending section 303, as amended by Public Law No. 8-97, to add a new subsection 4, and by renumbering subsections 4 through 9, for the purpose of allowing national election commissioners to authorize their respective State election commissioners to designate special polling places in any State within the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 303 of title 9 of the Code of the 2 Federated States of Micronesia, as amended by Public Law 3 No. 8-97, is hereby further amended to read as follows: "Section 303. Powers and duties of mational 4 5 election commissioner. A national election 6 commissioner shall have responsibility for the overall supervision and administration of the 8 election within his State and shall perform such duties as are prescribed by law, which include, but 9 10 are not limited to the following: 11 (1) to appoint all members of the several boards of election in his or her State as provided 12 13 for in this title; 14 (2) to require such reports from the several 15 boards as may be required by law or-regulation or as 16 the national election commissioner may deem 17 necessary; 18 to establish voting precincts within each election district and designate appropriate polling 19 20 places within each voting precinct, upon recommendations of the members of the board of 21 22 election of the particular election district; 23 (4) to designate special polling places in 24 States other than his or her own within the

Federated States of Micronesia and to appoint a

2	consisting of not less than two members;
3	(45) to receive nomination petitions;
4	$(\frac{1}{2})$ to list all candidates for election on
5	the ballot for each election district in
6	alphabetical order;
7	(67) to register or cause to be registered all
8	the voters in his State and to maintain the General
9	State Register as provided in this title;
10	(78) to prepare from the General State
11	Register a registered voters list for each voting
12	precinct prior to any election;
13	(\$9) to promulgate in accordance with chapter
14	1 of title 17 of this code local rules and
15	regulations which are consistent with rules and
16	regulations promulgated by the National Election
17	Director pursuant to section 302 of chapter 3 of
18	this title; and
19	(\$10) to assist the National Election Director
20	in maintaining the national election register."
