## A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by amending section 402 to apply the competitive bidding and other provisions of chapter 4 of title 55 to all allottees of appropriations of the Congress of the Federated States of Micronesia, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: 1 Section 1. Section 402 of title 55 of the Code of the 2 Federated States of Micronesia is hereby amended to read as 3 follows: 4 "Section 402. <u>Definitions</u>. As used in this 5 chapter: 'Citizen bidder' means: 6 (1)(a) until the termination of the 7 Trusteeship, any business in which at least fifty-Я 9 one percent of the interest therein is owned by a citizen or citizens of the Trust Territory of the 10 Pacific Islands; 11
  - (b) upon termination of the Trusteeship, any business in which at least fifty-one percent of the interest therein is owned by a citizen or citizens of the Federated States of Micronesia;
- (c) until the termination of the 16 Trusteeship, a business which has been a resident of 17 the Trust Territory of the Pacific Islands for at 1.8 least one year immediately prior to the submission 19 of its bid; 20
- upon termination of the Trysteeship, 21 a business which has been a resident of the 22 23 Federated States of Micronesia for at least one year immediately prior to the submission of its bid; and 24
- 25 upon termination of the Trusteeship,

1		a business which has paid gross revenue taxes to the
2		Federated States of Micronesia for the one year
3		period immediately prior to the submission of its
4		bid.
5		(2) 'Contracting officer' means the official
6		in charge of letting a contract for a National
7		Government agency.
8		(3) 'Lowest responsible bidder' means the
9		lowest bidder whose offer adequately responds in
10		quality, fitness, and capacity to the particular
11		requirements of the proposed work called for by the
12		contract.
13		(4) 'National Government agency' means any
14		branch, department, office, division, board, bureau,
15		commission, committee, institution, or authority of
16		the National Government of the Federated States of
17		Micronesia, and includes an allottee of funds
18		appropriated by the Congress of the Federated States
19		of Micronesia, when acting in such capacity."
20	Sectio	n 2. This act shall become law upon approval by
21	the Preside	ent of the Federated States of Micronesia or upon
22	its becomin	ng law without such approval.
