A BILL FOR AN ACT

To further amend Public Law No. 6-97, as amended by Public Laws Nos. 7-100 and 9-157, by amending sections 3 and 5, to modify the use of the funds previously appropriated therein for political education on proposed amendments to the Constitution of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 3 of Public Law No. 6-97, as amended
- 2 by Public Law No. 7-100, is hereby further amended to read as
- 3 follows:
- 4 "Section 3. Appropriation. The sum of \$200,000, or
- 5 so much thereof as may be necessary, is hereby
- 6 appropriated from the General Fund of the Federated
- 7 States of Micronesia for the fiscal year ending September
- 8 30, 1991, for political education on proposed amendments
- 9 to the Constitution of the Federated States of Micronesia
- 10 adopted by the Constitutional Convention and the
- 11 Congress; PROVIDED, however, that if any balance of the
- 12 funds appropriated herein and apportioned pursuant to
- subsections (1), (2), (3) and (4) of section 4 remains
- 14 unexpended subsequent to the referendum on the proposed
- amendments, then such balance may be expended for unpaid
- 16 expenses of the referendum and unpaid expenses of the
- 17 1991 National Election.
- 18 (a) If any balance of the funds appropriated in
- 19 section 3 remains unexpended, then such balance may be
- 20 expended as follows: up to \$14,400 may be used to pay
- 21 the costs incurred in transporting ballot boxes to and
- from polling places during the March 1997 National
- 23 Election; up to \$900 may be expended to reimburse the Yap
- 24 Delegation to the Congress of the Federated States of
- Micronesia for costs incurred by it in the March 1997

1	National Election associated with such transportation;
2	and up to $$19,500$ $$24,500$ may be used for the March 1997
3	and 1995 National Elections."
4	Section 3. Section 5 of Public Law No. 6-97 is hereby
5	amended to read as follows:
6	"Section 5. Management of funds and lapse date.
7	The allottee of funds appropriated by this act shall be
8	the President of the Federated States of Micronesia or
9	his designee. All funds appropriated under this act
10	shall be allotted, managed, administered, and accounted
11	for in accordance with the Financial Management Act of
12	1979. The authority of the allottee to obligate funds
13	appropriated by this act shall not lapse, except as to
14	the authority of the allottee to obligate funds in
15	accordance with section 3(a) of this act; such authority
16	shall lapse at the end of fiscal year 1997 1998.
17	Section 4. This act shall become law upon approval by
18	the President of the Federated States of Micronesia or upon its
19	becoming law without such approval.
