A BILL FOR AN ACT

To further amend title 54 of the Code of the Federated States of Micronesia, as amended, by further amending section 805, as amended by Public Laws Nos. 7-41 and 9-139, to provide that the States shall receive ninety-five percent of the net taxes collected pursuant to section 221(9) of said title, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section	on 1. Section 805 of title 54 of the Code of the Federated States of
2	Micronesia, a	as amended by Public Laws Nos. 7-41 and 9-139, is hereby further
3	amended to	read as follows:
4		"Section 805. <u>Distribution of revenues</u> .
5		(1) The treasurer of the Federated States of Micronesia
6		shall pay #i/ght/y ninety-five percent of the net taxes collected
7		pursuant to section 221(9) of this title, and fifty percent of all
8		other net taxes collected pursuant to sections 121, 141, and 221
9		of this title, into the treasury of the State government to which the
0		taxes are attributable for appropriation by the State legislature.
1		(2) 'Net taxes' as used in subsection (1) of this section
2		means gross collections of taxes, penalties, interest, or other
3		related charges less refunds and less the cost of administration.
4		(3) 'Cost of administration' as used in subsection (2) of
5		this section means the cost determined to be allocatable to each
6		State by the Congress of the Federated States of Micronesia when
7		making appropriations for the operating expenses of the <u>Customs</u>
8		and Revenue Divisions.
9		(4) The revenue office in each State may administer the
20		taxes of the State in which located, but those duties shall not
21		interfere with the administration of taxes imposed by the laws of
22		the Federated States of Micronesia. All costs in excess of those
23		funded by appropriations of the Congress of the Federated States
24		of Micronesia required for the administration of State taxes shall
5		he horne entirely by the State"
