A BILL FOR AN ACT

To further amend title 55 of the Code of the Federated States of Micronesia, as amended, by adding a new subchapter X of chapter 6, for the purpose of establishing the Micronesian Maritime Fisheries Academy Subsidy Fund, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Chapter 6 of title 55 of the Code of the
2	Federated States of Micronesia is hereby further amended
3	by adding a new subchapter X, to be headed as follows:
4	"Subchapter X. Micronesian Maritime Fisheries
5	Academy Subsidy Fund."
6	Section 2. Chapter 6 of title 55 of the Code the
7	Federated States of Micronesia is hereby amended by
8	adding a new section 670 of subchapter X, to read as
9	follows:
10	"Section 670. Establishment; Purpose. There is
11	hereby created and established the Micronesian
12	Maritime Fisheries Academy subsidy fund ("MMFA
13	subsidy fund"), separate from the General Fund of
14	the Federated States of Micronesia and all other
15	funds. The purpose of this fund shall be to
16	provide a subsidy to the Micronesian Maritime
17	Fisheries Academy to aid it in promoting the
18	training of Micronesian citizens in matters related
19	to the fishing and fisheries industry."
20	Section 3. Chapter 6 of title 55 of the Code of the
21	Federated States of Micronesia is hereby further amended
22	by adding a new section 671 of subchapter X, to read as
23	follows:
24	"Section 671. Deposits; Authorization. Each fiscal
25	year, two percent (2%) or \$150,000, whichever is

1	less, of monetary fees received pursuant to section
2	402 of title 24 of the Code of the Federated States
3	of Micronesia shall be deposited into the MMFA
4	subsidy fund. Such funds are hereby authorized for
5	disbursement without further appropriation."
6	Section 4. Chapter 6 of title 55 of the Code of the
7	Federated States of Micronesia is hereby further amended
8	by adding a new section 672 of subchapter X, to read as
9	follows:
10	"Section 672. Administration; Reversion.
11	The allottee of the funds authorized by this
12	subchapter shall be the President of the Federated
13	States of Micronesia, or his designee. All funds
14	authorized by this subchapter shall be allotted,
15	managed, administered, and accounted for in
16	accordance with applicable law, including, but not
17	limited to, the Financial Management Act of 1979.
18	The allottee shall be responsible for ensuring that
19	these funds, or so much thereof as may be
20	necessary, are used solely for the purpose
21	specified in this subchapter, and that no
22	obligations are incurred in excess of the sum
23	authorized. Funds that have not been obligated at
24	the close of the fiscal year following the fiscal
25	year in which received shall revert to the General

2	Section 5. Chapter 6 of title 55 of the Code of the
3	Federated States of Micronesia is hereby further amended
4	by adding a new section 673 of subchapter X, to read as
5	follows:
6	" <u>Section 673. Annual report</u> .
7	The President or his designee shall report to the
8	Congress of the Federated States of Micronesia on
9	the status of the MMFA subsidy fund at the close of
10	each fiscal year."
11	Section 6. This act shall become law upon approval by
12	the President of the Federated States of Micronesia or
13	upon its becoming law without such approval.
