## A BILL FOR AN ACT

To amend Public Law No. 10-120 for the purpose of changing the apportionment of certain funds appropriated therein, to change the allottee of certain funds, and for other purposes.

1	Section 1. The sum of \$5,000,000, or so much thereof as
2	may be necessary, is hereby appropriated from the General Fund of
3	the Federated States of Micronesia for the fiscal year ending

Section 4. The sum of \$1,000,000, or so much thereof as may be
necessary, is hereby appropriated from the General Fund of the

7	than 10% of any project appropriation contained herein may be used
8	for the administrative costs associated with the project, including
9	the costs of a project inspector. Where the allottee under this act
10	is an official or employee of a State government, no project
11	inspector selected by the allottee shall be disqualified on the
12	grounds that he is a State official or employee.
13	Section 6. All funds appropriated by this act shall be
14	allotted, managed, administered, and accounted for in accordance
15	with applicable law, including, but not limited to, the Financial
16	Management Act of 1979. The allottee of the funds appropriated
17	under sections 1(1), 1(3)(e) and 1(3)(f) of this act shall be the
18	Governor of the State of Chuuk or his designee. The allottee of the
19	funds appropriated under section 1(2) of this act shall be the
20	Speaker of the Congress of the Federated States of Micronesia. The
21	allottee of the funds appropriated under sections 1(3)(a) and
22	1(3)(g) of this act shall be the Director of the Department of
23	Health Services. The allottee of the funds appropriated under
24	sections 1(3)(c) and 1(3)(d)of this act shall be the Executive
25	Director of the Chuuk Recreation Office. The allottee of the funds

shall be the Governor of the State of Yap. The allottee of the 1 funds appropriated under section 4(8) of this act shall be the 2 Speaker of the Congress of the Federated States of Micronesia. The 3 allottee of all other funds appropriated by this act shall be the 4 President of the Federated States of Micronesia or the President's 5 designee. In the event that the President designates the Vice 6 7 President as allottee, the Vice President may designate a suballottee. The allottees shall be responsible for ensuring that 8 9 these funds, or so much thereof as may be necessary, are used solely 10 for the purpose specified in this act, and that no obligations are 11 incurred in excess of the sum appropriated. No allottee of funds 12 appropriated under section 2(1) of this act shall obligate funds without first consulting with the member of the Kosrae delegation to 13 14 the Congress of the Federated States of Micronesia. The allottee of 15 funds set aside for projects in Pohnpei Election District No. 2 16 under section 3 of this act shall not obligate funds without first 17 consulting with the member of the Congress of the Federated States 18 of Micronesia representing that district, and said allottee shall obligate no more than ten percent of such funds for administrative 19 20 costs. The authority of the allottees to obligate funds appropriated by this act shall lapse as of September 30, 2001. 21 22 23
