A BILL FOR AN ACT

To appropriate the sum of \$2,810,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, for the purpose of funding certain FSM projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$1,010,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 1999, for the purpose of funding certain national projects and
5	programs. The funds appropriated herein shall be apportioned as
6	follows:
7	(1) March, 1999 CFSM elections\$ 300,000
8	(2) JCN supplemental funding 200,000
9	(3) National Fisheries Corporation subsidy 250,000
10	(4) Mortlocks airport paving/soil cement
11	(which shall be deemed to come from the capital
12	account section 211 of the Compact of Free Association). 200,000
13	(5) Other expenses of National government
14	programs
15	(a) Overtime compensation for national
16	government employees (as allowed by title 52 section
17	509 of the FSM Code)
18	(b) Overtime, 2nd FSM Games
19	(c) Expenses for housing of athletes,
20	August, 1998 Micronesian Games
21	Section 2. The sum of \$750,000, or so much thereof as may be
22	necessary, is hereby appropriated from the General Fund of the
23	Federated States of Micronesia for the fiscal year ending September
24	30, 1999, for the purpose of funding health, education,
25	infrastructure and other public projects and programs in the State

- 1 of Chuuk.
- 2 Section 3. The sum of \$550,000, or so much thereof as may be
- 3 necessary, is hereby appropriated from the General Fund of the
- 4 Federated States of Micronesia for the fiscal year ending September
- 5 30, 1999, for the purpose of funding health, education,
- 6 infrastructure and other public projects and programs in the State
- 7 of Pohnpei.
- 8 Section 4. The sum of \$350,000, or so much thereof as may be
- 9 necessary, is hereby appropriated from the General Fund of the
- 10 Federated States of Micronesia for the fiscal year ending September
- 11 30, 1999, for the purpose of funding health, education,
- 12 infrastructure and other public projects and programs in the State
- 13 of Yap.
- Section 5. The sum of \$150,000, or so much thereof as may be
- 15 necessary, is hereby appropriated from the General Fund of the
- 16 Federated States of Micronesia for the fiscal year ending September
- 17 30, 1999, for the purpose of funding health, education,
- 18 infrastructure and other public projects and programs in the State
- 19 of Kosrae.
- 20 Section 6. All funds appropriated by this act shall be
- 21 allotted, managed, administered, and accounted for in accordance
- 22 with applicable law, including, but not limited to, the Financial
- 23 Management Act of 1979. The allottee of the funds appropriated
- 24 under section 1(4) of this act shall be the Secretary of Department
- 25 of Transportation, Communication and Infrastructure. The allottee
- 26 of the funds appropriated under section 4 of this act shall be the

1	Governor of the State of Yap. The allottee of all other funds
2	appropriated by this act shall be the President of the Federated
3	States of Micronesia or the President's designee. The allottees
4	shall be responsible for ensuring that these funds, or so much
5	thereof as may be necessary, are used solely for the purpose
6	specified in this act, and that no obligations are incurred in
7	excess of the sum appropriated. The authority of the allottee to
8	obligate funds appropriated under section 1(1) to 1(3) and 1(5) of
9	this act shall lapse as of September 30, 1999. The authority of the
10	allottees to obligate all other funds appropriated by this act shall
11	lapse as of September 30, 2000.
12	Section 7. This act shall become law upon approval by
13	the President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
