A BILL FOR AN ACT

To appropriate the sum of \$52,094 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1999, to fund the President's National Advisory Council on Children (PNACC) for recruitment of a Commissioner of the Convention on the Rights of the Child; a PNACC delegation's participation in the Fourth Ministerial Consultation Meeting on the Convention on the Rights of the Child, scheduled to be held in Bangkok, Thailand on November 12-14, 1998; administrative and travel expenses associated with finalization of the PNACC's Plans of Action for Children in each FSM State; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The Congress of the Federated States of
- 2 Micronesia recognizes the important work of the President's
- 3 National Advisory Council on Children (PNACC) in implementing
- 4 the United Nations Convention on the Rights of the Child. The
- 5 purpose of this appropriation is to provide the PNACC with
- 6 sufficient funding to work toward its mission in the 1999
- 7 fiscal year, including sufficient funding to recruit and train
- 8 a Commissioner of the Convention on the Rights of the Child to
- 9 serve as the PNACC's Chief Executive Officer, to send a
- 10 delegation to participate in the Fourth Ministerial
- 11 Consultation Meeting on the Convention on the Rights of the
- 12 Child, scheduled to be held in Bangkok, Thailand on November
- 13 12-14, 1998, for the purpose of reviewing progress made toward
- 14 the FSM's commitments at the World Summit for Children in 1990,
- 15 and to cover travel and administrative expenses associated with
- 16 finalizing Plans of Action for Children in each of the four FSM
- 17 States.
- Section 2. The sum of \$52,094, or so much thereof as may
- 19 be necessary, is hereby appropriated from the General Fund of
- 20 the Federated States of Micronesia for the fiscal year ending
- 21 September 30, 1999, for the purpose of recruiting and training
- 22 a Commissioner of the Convention on the Rights of the Child,
- 23 funding an FSM delegation to the Fourth Ministerial
- 24 Consultation Meeting on the Convention on the Rights of the
- 25 Child, funding travel and administrative expenses associated
