## A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended by Public Laws Nos. 10-122 and 10-144, by further amending section 4, as amended by Public Law No. 10-122, for the purpose of reprogramming funding and modifying the use of funds appropriated therein for the State of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 4 of Public Law No. 10-120, as amended by
2	Public Law No. 10-122, is hereby further amended to read as follows:
3	"Section 4. The sum of \$1,000,000, or so much thereof as
4	may be necessary, is hereby appropriated from the General
5	Fund of the Federated States of Micronesia for the fiscal
6	year ending September 30, 1999, for the purpose of
7	funding infrastructure and other projects and programs in
8	the State of Yap. The funds appropriated under this
