## A BILL FOR AN ACT

To appropriate the sum of \$150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding the operations of the Rural Development (USDA) offices, and for other purposes.

## BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$150,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 2000, for the operations of the Rural Development (USDA) offices
5	during the fiscal year 2000. The sum appropriated by this section
6	shall be apportioned as follows:
7	(1) Pohnpei\$ \$67,500
8	(2) Chuuk, for technical and support staff
9	cost only (no travel, no regular staff
10	salary, no overtime and no vehicle purchase). 37,500
11	(3) Kosrae
12	(4) Yap 15,000"
13	Section 2. Allotment and management of funds and lapse date.
14	(1) All funds appropriated by this act shall be
15	allotted, managed, administered, and accounted for in accordance
16	with applicable law, including, but not limited to, the Financial
17	Management Act of 1979. The allottees of the funds appropriated by
18	this act shall be the Rural Development Community Development
19	Managers of the respective states; PROVIDED that funds appropriated
20	under this act shall not be disbursed to an allottee if he fails to
21	submit to the Speaker of Congress and the President of the Federated
22	States of Micronesia detailed quarterly financial statements
23	regarding his office's operations, or if he fails to comply with the
24	Financial Management Act of 1979. The allottees shall be
25	responsible for ensuring that these funds, or so

1	much thereof as may be necessary, are used solely for the purpose
2	specified in this act, and that no obligations are incurred in
3	excess of the sum appropriated.
4	(2) The authority of the allottees to obligate funds
5	appropriated by this act shall lapse as of September 30, 2000.
6	Section 3. This act shall become law upon approval by the
7	President of the Federated States of Micronesia or apon its becoming
8	law without such approval.
