CONGRESSIONAL BILL NO. 11-118, C.D.1, C.D.2, C.D.3, C.D.4, C.D.5

### AN ACT

To appropriate the sum of \$2,750,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding a Priority State Infrastructure Project (PSIP) Fund, from which the States can fund priority projects, and to fund State regional projects, and for other purposes.

- BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. The sum of \$2,750,000, or so much thereof as may be 1 necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2000, for the purpose of funding a Priority State Infrastructure Project (PSIP) Fund, from which the States can fund priority projects, and to fund State regional projects. Section 2. The sum appropriated under section 1 of this act 7 shall be apportioned as follows: (1) Priority State Infrastructure Project (PSIP) Fund, 9 PROVIDED that, Congress may, from time to time, make additional appropriations into this Fund, and PROVIDED FURTHER that, the

16	funds appropriated under section 2(2)(a), 2(2)(b), and 2(2)(d) of this
17	act shall be the President of the Federated States of Micronesia, or
18	his designee, who shall consult with the appropriate State's
19	Congressional delegation prior to the obligation and disbursement of
20	any funds. The allottee of the funds appropriated under section
21	2(2)(c) of this act shall be the Executive Director of the Chuuk State
22	Commission on Improvement Projects or his designee. Each allottee
23	shall be responsible for ensuring that the funds allotted to him, or
24	so much thereof as may be necessary, are used solely for the purpose
25	specified in this act, and that no obligations are incurred

BE	IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$6,000,000, or so much thereof as may be
