A BILL FOR AN ACT

To further amend Public Law No. 6-74, as amended, by further amending section 5, as amended by Public Laws Nos. 6-101, 7-72, 8-152, 9-061, 9-141, and 10-105, to extend the lapse date to September 30, 1999, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 6-74, as amended
2 by Public Laws Nos. 6-101, 7-72, 8-152, 9-061, 9-141, and 10-
3 105, is hereby further amended to read as follows:

4 "Section 5. Allotment and management of funds and
5 lapse date.

6 (1) All funds appropriated by this act shall be
7 allotted, managed, administered, and accounted for in
8 accordance with applicable law, including, but not
9 limited to, the Financial Management Act of 1979.
10 The allottee of the funds appropriated under
11 paragraphs (a), (b), (c) and (d) of subsection (1) of
12 section 1 of this act shall be the Chief Magistrate
13 of the Sokehs Municipal Government. The allottee of
14 the funds appropriated under subsection (2) of
15 section 1 of this act shall be the Kolonia Town
16 Mayor. The allottee of the funds appropriated under
17 subsection (3) of section 1 of this act shall be the
18 Luhkenkolwof of Sapwuahfik. The allottee of the
19 funds appropriated under subsection (4) of section 1
20 of this act shall be the Chief Magistrate of the
21 Nukuoro Municipal Government. The allottee of the
22 funds appropriated under subsection (5) of section 1
23 of this act shall be the Chief Magistrate of the
24 Kapingamarangi Municipal Government. The allottee of
25 the funds appropriated under subsections (6) and (7)

1 of section 1 of this act shall be the Chief
2 Magistrate of the Sokehs Municipal Government. The
3 allottee of the funds appropriated under subsections
4 (1) and (2) of section 2 and paragraph (3)(a) of
5 section 2 of this act shall be the Menin Keder
6 Lapalap of the Madolenihmw Municipal Government. The
7 allottee of the funds appropriated under paragraph
8 (3)(b) of section 2 shall be the Madolenihmw
9 Municipal Government. The allottee of the funds
10 appropriated under subsections (4) and (5)(a) of
11 section 2 and paragraph (6)(a) of section 2 of this
12 act shall be the Luhkenmenlap of the Kitti Municipal
13 Government. The allottee of the funds appropriated
14 under paragraph (5)(b) of section 2 of this act shall
15 be the President of the Federated States of
16 Micronesia. The allottee of the funds appropriated
17 under paragraph (6)(b) of section 2 of this act shall
18 be the Kitti Municipal Government. The allottees of
19 the funds appropriated under subsections (1), (2),
20 (4) and (5) of section 2 of this act and paragraphs
21 (3)(a) and (6)(a) of section 2 of this act shall
22 submit detailed funds status and project status
23 reports to the Congress of the Federated States of
24 Micronesia at the beginning of each quarter of each
25 fiscal year. The allottee of the funds appropriated


1 under paragraphs (e), (f), (g), (h) and (i) of
2 subsection (1) of section 1; paragraphs (b), (c),
3 (d), (e) and (f) of subsection (1) of section 3; and
4 section 4 of this act shall be the President of the
5 Federated States of Micronesia or the President's
6 designee; PROVIDED, however, that the funds allotted
7 under subsection (6) of section 1 of this act shall
8 not be allotted before October 1, 1990. The allottee
9 of the funds appropriated under subsection (1)(a) of
10 section 3 of this act shall be the Pohnpei
11 Transportation Authority. The allottee of the funds
12 appropriated under subsection (2) of section 3 of
13 this act shall be the Coconut Development Authority.
14 The allottees shall be responsible for ensuring that
15 these funds, or so much thereof as may be necessary,
16 are used solely for the purpose specified in this
17 act, and that no obligations are incurred in excess
18 of the sum appropriated.

19 (2) The authority of the allottee to obligate
20 funds appropriated by this act shall lapse as of [May
21 ~~31~~ September 30, 1999."

3 law without such approval.
