

A BILL FOR AN ACT

To further amend Public Law No. 11-54, as amended by Public Laws Nos. 11-56, 11-63, 11-67 and 11-73, by amending section 6 to provide funding for the Office of National Election Director, and by further amending section 8, as amended by Public Laws Nos. 11-67 and 11-73, to provide funding for the special election to be held in Pohnpei State Election District No. 2 on June 30, 2001, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 11-54 is hereby amended to
2 read as follows:

3 "Section 6. Operating expenses of agencies of the National
4 Government. The sum of [~~\$1,701,498~~] \$1,815,498, or so much
5 thereof as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for the
7 fiscal year ending September 30, 2001, for the operations of
8 the following boards, commissions and agencies during fiscal
9 year 2001. The sum appropriated by this section shall be
10 apportioned as follows:

11 (1) Micronesian [~~Maritime~~] Fisheries Authority
12 \$441,795 for the outputs set forth in pages E-1-5 through E-1-
13 7 of the budget book.

14 (2) Board of Regents-COM-FSM
15 \$78,960 for the outputs set forth in page E-2-4 of the budget
16 book.

17 (3) FSM Coconut Development Authority

1 \$137,258 for the outputs set forth in page E-3-4 of the budget
2 book.

3 (4) FSM Banking Board
4 \$158,005 for the outputs set forth in page E-4-4 of the budget
5 book.

6 (5) FSM Postal Service
7 \$610,480 for the outputs set forth in pages E-5-5 through E-5-
8 6 of the budget book; PROVIDED that, prior to October 1, 2000,
9 the FSM Postal Service provides to the Committee on Judiciary
10 and Governmental Operations of the Congress of the Federated
11 States of Micronesia, through its chairman, a full allocation
12 of the funds appropriated across such outputs, with related
13 deliverables.

14 (6) FSM National Fisheries Corporation
15 \$275,000 to subsidize the flight operations of the National
16 Fisheries Corporation and repayment of OPIC loan.

17 (7) Office of the National Election Director
18 \$114,000 for operations of the Office of the National Election
19 Director through September 30, 2001."

20 Section 2. Section 8 of Public Law No. 11-54, as amended by Public
21 Laws Nos. 11-67 and 11-73, is hereby further amended to read as
22 follows:

23 "Section 8. Grants, subsidies and contributions. The sum of
24 [~~\$3,963,248~~] \$3,849,248, or so much thereof as may be
25 necessary, is hereby appropriated from the General Fund of the

1 Federated States of Micronesia for the fiscal year ending
 2 September 30, 2001, for the following grants, subsidies and

 4 by this section shall be apportioned as follows:
