

A BILL FOR AN ACT

To further amend Public Law No. 9-027, as amended, by amending section 5 to change the allottee for funds appropriated for medical needs in E.D. No. 1 of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-027, as amended by
2 Public Law No. 10-65, is hereby further amended to read as follows:

3 "Section 5. Allotment and management of funds and lapse
4 date.

5 (1) All funds appropriated by this act shall be allotted,
6 managed, administered, and accounted for in accordance with
7 applicable law, including, but not limited to, the Financial
8 Management Act of 1979. [~~All funds appropriated herein shall~~
9 ~~not lapse until fully expended~~]. The allottee of the funds
10 appropriated under subsection (1) of section 1 of this act
11 shall be the Director of Health Services, Chuuk State. The
12 allottee of the funds appropriated under subsection (2) of
13 section 1 of this act shall be the Mayor of Polle
14 Municipality. The allottee of the funds appropriated under
15 subsection (3) of section 1 of this act shall be the
16 [~~Southern Namoneas Authority~~] Chuuk State Commission on
17 Improvement Projects. The allottee of the funds appropriated
18 under subsection (4) of section 1 of this act shall be the
19 Northern Namoneas Development Authority. The allottee of the

1 funds appropriated under subsection (5) of section 1 of this
2 act shall be the [~~Mortlocks Development Authority~~] Vice
3 President of the Federated States of Micronesia, or his
4 designee. The allottee of the funds appropriated under
5 subsection (6) of section 1 of this act shall be the Pattiw
6 Development Authority. The allottee of the funds
7 appropriated under section 2 of this act shall be the
8 Governor of Pohnpei State. The allottee of the funds
9 appropriated under section 3 of this act shall be the
10 Governor of Yap State. The allottee of the funds
11 appropriated under section 4 of this act shall be the
12 Governor of Kosrae State. The allottees shall be responsible
13 for ensuring that these funds, or so much thereof as may be
14 necessary, are used solely for the purpose specified in this
15 act, and that no obligations are incurred in excess of the
16 sum appropriated.

17 (2) All funds appropriated herein shall not lapse until
18 fully expended."

19 Section 2. This act shall become law upon approval by the
20 President of the Federated States of Micronesia or upon its becoming
21 law without such approval.
