

A BILL FOR AN ACT

To further amend Public Law No. 13-36, as amended, by amending sections 4 and 5 thereof to change the use and allottee of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 13-36, as
2 amended by Public Laws Nos. 13-49, 13-66, 13-83, 13-90 and
3 14-31, is hereby further amended to read as follows:

4 "Section 4. The sum of \$960,000, or so much thereof as
5 may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2004, to provide
8 funding for social and economic development projects in
9 the State of Chuuk. The funds appropriated under this
10 section shall be apportioned as follows:

6 Section 2. Section 5 of Public Law No. 13-36, as amended by
 7 Public Laws Nos. 13-49, 13-66, 13-80, 13-83 and 14-5, is
 8 hereby further amended to read as follows:

9 "Section 5. Allotment and management of funds and lapse
 10 date.

11 (1) All funds appropriated by this act shall be allotted,
 12 managed, administered, and accounted for in accordance with
 13 applicable law, including but not limited to, the Financial
 14 Management Act of 1979. The allottee of the funds
 15 appropriated under sections 1, 2 and 3 of this act shall be
 16 the President of the Federated States of Micronesia or his
 17 designee, except that the allottee of the funds appropriated
 18 under subsections 1(1), 1(3) and 1(4) of this act shall be
 19 the Governor of the State of Kosrae; the allottee of the
 20 funds appropriated under sections 2(3), 2(4) and 2(7)
 21 through 2(11) of this act shall be the Governor of the State
 22 of Yap; the allottee of the funds appropriated under
 23 sections 2(5) and 2(6), shall be the Speaker of Congress;
 24 the allottee of the funds appropriated under subsection
 25 3(2) (a) (i) shall be the mayor of Kolonia Town; the allottee

1 of the funds appropriated under subsections 3(2)(a)(ii),
2 3(2)(a)(iv) and 3(2)(a)(v) shall be the Sokehs magistrate;
3 the allottee of the funds appropriated under subsection
4 3(2)(a)(iii) shall be the mayor of Nukuoro; and the allottee
5 of funds appropriated under subsections 3(2)(c)(v) and
6 3(2)(c)(vi) shall be the Pohnpei Transportation Authority.
7 The allottee of the funds appropriated under section 4 of
8 this act shall be the Chuuk State Commission on Improvement
9 Projects, [~~except that the funds appropriated under section~~
10 ~~4(1)(c) of this act shall be allotted to the President of~~
11 ~~the Federated States of Micronesia and the funds~~
12 ~~appropriated under section 4(1)(d) of this act shall be~~
13 ~~allotted to the Mayor of Polle Municipality]~~.

14 (2) The allottees of the funds appropriated herein
15 shall be responsible for ensuring that these funds, or
16 so much thereof as may be necessary, are used solely
17 for the purpose specified herein, and shall report back
18 to the Congress on the status of these funds no later
19 than September 30, 2005. The authority of the
20 allottees to obligate such funds shall not lapse until
21 fully expended.

24 Section 3. This act shall become law upon approval by the
25 President of the Federated States of Micronesia or upon its

1 becoming law without such approval.
