Dear Speaker Figir:

I am signing Congressional Act 15-41 into Public Law No. 15-37 but not in its entirety. This line-item veto is premised on the fact that the \$22,364 has already been lapsed into the General Fund, not the "FY 2006 Project Funds" as mandated by Public Law 14-35.

Additionally, I would note for your consideration that the language in this Act stating that the funds are re-appropriated from the General Fund "for fiscal year ending September 30, 2006" should be amended to read "for fiscal year ending September 30, 2008," as well as deleting the language pertaining to Section 5, (2) (a) of the Act.


We stand ready to discuss the matter in detail should there be a need.

AN ACT

To further amend Public Law No. 14-84, as amended, by amending the Section 5 thereof, to change the use of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 14-84, as amended by
2 Public Laws Nos. 14-96 and 14-103, is hereby further amended to
3 read as follows:

4 "Section 5. The sum of \$46,372 or so much thereof as
5 may be necessary that lapsed as of June 30, 2006 or as
6 required by Public Law No. 14-35 from Public Laws Nos.
7 8-100, 9-052, 9-095, 10-120, 10-126, 10-143 and 11-59 is
8 hereby reappropriated from the General Fund of the
9 Federated States of Micronesia for the fiscal year
10 ending September 30, 2006, for the purpose of funding
11 projects and social programs for Election District No. 1
12 and the sum of \$22,364 or so much thereof as may be
13 necessary that lapsed as of June 30, 2006 as required by
14 Public Law No. 14-35 from Public Laws Nos. 6-113, 8-100
15 and 9-095 for Election District No. 2, Pohnpei State, is
16 hereby reappropriated from the General Fund of the
17 Federated States of Micronesia for the fiscal year
18 ending September 30, 2006, for the purpose of funding
19 projects and social programs for Election District No.
20 2, Pohnpei State as follows:
