

AN ACT

To amend Public Law No. 15-31 by amending section 1 thereof, to change the use of certain funds previously appropriated therein for the State of Pohnpei, and for other purposes.

BE	IT ENACTED BY THE	CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
