PUBLIC LAW No. 15-66

AN ACT

To appropriate \$1,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, for the purpose of funding public projects and social programs in the States of Chuuk, Yap, Pohnpei and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Shall read as follows: To appropriate the sum of

8	these funds shall be the Governor of Yap State or his designee;
9	(c) Subsection 3 of Section 1 — the allottee of
10	these funds shall be the President of the Federated States of
11	Micronesia;
12	(d) Subsection 4 of Section 1 — the allottee of
13	these funds shall be the Chuuk State Commission on Improvement
14	Projects;
15	<u>Lapse Date</u> . The authority of the allottee to obligate
16	funds appropriated by this act shall not lapse until fully
17	expended.
