

PUBLIC LAW No. 15 - 67

AN ACT

To appropriate the sum of \$271,537, from the General Fund of the Federated States of Micronesia for the purpose of funding the upcoming FSM Public Safety Academy, Caroline Island Air Inc, T-3 Program, Office of Statistics, Budget, Overseas Development Assistance and Compact Management, Chuuk Office of National Public Auditor, Micronesia Seminar Project and former FSM Ambassador for the United States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERTED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$271,537, or so much thereof as may be
- 2 necessary, is hereby appropriated from the general fund of the
- 3 Federated States of Micronesia for the purpose of funding the FSM
- 4 Public Safety Academy and matching a \$107,000 technical assistance
- 5 grant from the Office of Insular Affairs, United States Department
- 6 of Interior to be used for the academy, Caroline Island Air Inc,
- 7 one month funding for T-3 Program, one month funding for Office of
- 8 Statistics, Budget, Overseas Development Assistance and Compact
- 9 Management, one month operations of the Chuuk Office of the
- 10 National Public Auditor, Micronesian Seminar Project and former
- 11 FSM Ambassador to the United States. The sum of \$40,000
- 12 appropriated herein shall be used for the provisions and catering
- 13 component of the academy. The sum of \$166,537 appropriated herein
- 14 shall be used for the purpose of payment for operations, Aircraft
- 15 Insurance, Aircraft Accessories overhaul, Propeller Overhaul,
- 16 Engine Oil Lubricant and Aviation Gasoline. The sum of \$20,000

PUBLIC LAW No. 15 - 67

- 1 appropriated herein shall be used to fund the project of the
- 2 Micronesian Seminar to study the impact of outmigration. The sum
- 3 of 14,000 appropriated herein shall be used to fund money owed by
- 4 the government to the former FSM Ambassador to the United States.
- 5 The sum of \$7,300 appropriated herein shall be used to fund the
- 6 operations of the Chuuk office of the National Public Auditor for
- 7 one month. The sum of \$19,000 appropriated herein shall be used
- 8 to fund the operations of the T-3 program for one month of this
- 9 fiscal year 2009. The sum of \$4,700 appropriated herein shall be
- 10 used to fund two personnel positions in the Compact Division,
- 11 being the Health Sector Specialist and Education Sector
- 12 Specialist, for one month of this fiscal year 2009."
- 13 Section 2. Allotment and Management of Fund.
- 14 All funds appropriated by this act shall be allotted,
- 15 administered, and accounted for in accordance with applicable law,
- 16 including, but not limited to the Financial Management Act of
- 17 1979. The allottee of the funds appropriated by this Act shall be
- 18 the President of the Federated States of Micronesia or his
- 19 designee. The allottee or his designee shall be responsible for
- 20 ensuring that these funds are used in accordance with applicable
- 21 law. No obligation shall be incurred in excess of the sum
- 22 appropriated herein.
- 23 Section 3. Lapse Date. The funds appropriated by this act
- 24 shall lapse on September 30, 2009.
