Dear Speaker Figir:

Transmitted herewith is the following Congressional Act, which has become Public Law No. 16-23, without my signature.

Congressional Act No. 16-22, "AN ACT TO APPROPRIATE THE SUM OF \$199,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE PURPOSE OF FUNDING ECONOMIC AND SOCIAL PROJECTS AND PROGRAMS IN THE STATES OF KOSRAE, POHNPEI AND CHUUK, AND FOR OTHER PURPOSES."

This Act is a result of Public Law No. 16-18 where I disapproved a number of line items on legal and constitutional grounds. The appropriation made in this Act is a repetition of questionable line items I previously disapproved. In my view, re-passing the same line items does not obscure the concerns that were brought out before as those concerns remained unresolved up to this date. I offered certain recommendations concerning the need to revisit the budget procedures of this Nation in order to align public projects with the strategic plans and priorities. Those recommendations and concerns not being addressed in this Act furnish a valid basis for a Presidential veto. Nevertheless, I feel that Congress will easily override a veto as it did several times in the past making this an exercise in futility. I have therefore decided to allow this Act to become law without my signature.

I continue to hope that the new budget cycle for FY 2011 will provide us the invaluable tool and opportunity to put our heads together and jointly undertake a review of this Nation's budgeting process to make it more effective in addressing the needs of our people.

I thank you members of Congress for the effort spent on this matter and look forward to a more meaningful joint undertaking in the future on the same subject.
