Dear Speaker Figir:

While I support the need of public projects, there is also a need to ascertain the nexus between projects and the national strategic development plan. On several occasions in the past, I have indicated my concern of the link between specific item, to wit, "travel needs" or "leadership travel" and public projects. I reiterate this concern and reemphasize the need of our continued cooperation to work together to ascertain that public projects appropriation will support the national SDP.

Nevertheless, with a view toward continued cooperation between our branches and understanding that Congress would address the illuminated concerns, I hereby transmit the following Congressional Act, which I have approved to become Public Law No. 16-62:

Congressional Act 16-64 "AN ACT TO APPROPRIATE THE SUM OF \$1,050,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2011, FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS IN EACH OF THE FOUR STATES, AND FOR OTHER PURPOSES."

PUBLIC LAW No. 16-62

AN ACT

To appropriate the sum of \$1,050,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2011, for the purpose of funding public projects and social programs in each of the four states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$1,050,000, or so much thereof as may
2 be necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending
4 September 30, 2011, for the purpose of funding public projects and
5 social programs in each of the four states.

6 Section 2. Of the sum of \$1,050,000 appropriated by this act,
7 \$255,000 is apportioned for Kosrae State for public projects and
8 social programs.

22 Section 6. Allotment and management of funds and lapse date.

23 All funds appropriated by this act shall be allotted, managed,
 24 administered and accounted for in accordance with applicable law,
 25 including, but not limited to, the Financial Management Act of

1 1979. The allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used solely for
3 the purpose specified in this act, and that no obligations are
4 incurred in excess of the sum appropriated. The allottee of funds
5 appropriated under sections 2 and 4 of this act shall be the
6 President of the Federated States of Micronesia or his designee.
7 The allottee of funds appropriated under section 3 of this act
8 shall be the Governor of Yap State. The allottee of funds
9 appropriated under subsections 5(1)(2)(4)(5) and (6) shall be the
10 Chuuk State Commission on Improvement Project (CSCIP). The
11 allottee of funds appropriated under subsection 5(3) of this act
12 shall be the Executive Director of the Northern Namoneas Social
13 and Economic Development Authority. The funds appropriated by
14 this act shall remain available until fully expended.
