Dear Speaker Figir:


I am pleased to inform you that I have designated the following Congressional Act as Public Law No. 16-64:

Congressional Act No. 16-66, "AN ACT TO AMEND PUBLIC LAW NO. 16-58, BY AMENDING SECTION 3, 4 and 6 TO MODIFY THE USE AND THE ALLOTTEE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATES OF YAP AND POHNPEI FOR FISCAL YEAR 2011, AND FOR OTHER PURPOSES."

However, in passing this act, I would like to reiterate a concern that I have expressed in the past. Line items involving "leadership travel" or "travel needs" are vague and susceptible to misuse. I respectfully request that this issue be rectified by Congress in the future to ensure continued collaboration and efficiency between our respective branches.

AN ACT

To amend Public Law No. 16-58, by amending sections 3, 4 and 6 to modify the use and the allottee of certain funds previously appropriated to fund public projects and social programs in the States of Yap and Pohnpei for fiscal year 2011, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 16-58 is hereby
2 amended to read as follows:

3 "Section 3. Of the sum of \$1,005,000 appropriated by
4 this act, \$140,000 is apportioned for Yap State for
5 public projects and social programs.

17 Section 2. Section 4 of Public Law No. 16-58 is hereby
18 amended to read as follows:

"Section 4. Of the sum of \$1,005,000 appropriated by
this act, \$310,000 is apportioned for Pohnpei State for
public projects and social programs.

7 Section 3. Allotment and management of funds and lapse date.

8 All funds appropriated by this act shall be allotted, managed,
9 administered and accounted for in accordance with applicable law,
10 including, but not limited to, the Financial Management Act of
11 1979. The allottee shall be responsible for ensuring that these
12 funds, or so much thereof as may be necessary, are used solely for
13 the purpose specified in this act, and that no obligations are
14 incurred in excess of the sum appropriated. The allottee of funds
15 appropriated under sections 2 and 4 of this act shall be the
16 President of the Federated States of Micronesia or his designee.
17 The allottee of funds appropriated under section 3 of this act
18 shall be the Governor of Yap State, PROVIDED THAT the allottee of
19 funds appropriated under section 3(1)(e) of this act shall be the
20 President of the COM-FSM. The allottee of funds appropriated
21 under subsections 5(1)(2)(4)(5)(6) and (7) of this act shall be
22 the Chuuk State Commission on Improvement Project (CSCIP). The
23 allottee of funds appropriated under subsection 5(3) of this act
24 shall be the Executive Director of the Northern Namoneas Social
25 and Economic Development Authority. The funds appropriated by

1 this act shall remain available until fully expended.

2 Section 4. This act shall become law upon approval by the
3 President of the Federated States of Micronesia or upon its
4 becoming law without such approval.
