
I hereby designate as Public Law No. 17-20, the following Congressional Act:

Congressional Act No. 17-20, "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 16-58, AS AMENDED BY PUBLIC LAWS NOS. 16-64, 16-72 AND 17-11, BY AMENDING SECTION 4 THEREOF TO MODIFY THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF POHNPEI, AND FOR OTHER PURPOSES."

This congressional act amends existing appropriation for Pohnpei, by inserting the following additional line items: (a) Kepin Awak secondary road (\$15,000), (b) Pahndou bridge (\$6,666), (c) Road maintenance U municipal (\$3,000), (d) Takaiu cause way (\$1,878), and (e) U softball league tournament (\$200). The total amount of funding remains the same as prior appropriation.

AN ACT

To further amend Public Law No. 16-58, as amended by Public Laws Nos. 16-64, 16-72 and 17-11, by amending section 4 thereof to modify the use of certain funds previously appropriated to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 16-58, as amended
2 by Public Laws Nos. 16-64, 16-72 and 17-11, is hereby further
3 amended to read as follows:

4 "Section 4. Of the sum of \$1,005,000 appropriated by
5 this act, \$310,000 is apportioned for Pohnpei State for
6 public projects and social programs.


