Dear Speaker Halbert:

I am pleased to inform Congress that I signed the following Act became **Public Law No. 18-18** pursuant to Article IX Section 22 of the FSM Constitution:

Congressional Act No. 18-16, "AN ACT TO AMEND PUBLIC LAW NO. 14-84, AS AMENDED BY PUBLIC LAWS NOS. 14-96, 14-103, 14-108, 15-13, 15-37, 15-42, 15-53, 16-8, 16-44, 17-17 AND 17-61, BY AMENDING SECTION 9 THEREOF, TO CHANGE THE ALLOTTEE AND LAPSE DATE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATES OF CHUUK, KOSRAE, POHNPEI AND YAP, AND FOR OTHER PURPOSES."

As stated in its title, the Congressional Act extends the lapse date of public project appropriation up to September 30, 2014. It also replaced the Chuuk State Commission on Improvement Project (CSCIP) with the Governor of Chuuk as allottee of funds for public projects and social programs for the State of Chuuk. I thank Congress for passing this act.

CONGRESSIONAL BILL NO. 18-71, C.D.1

PUBLIC LAW No. 18- 18

AN ACT

To further amend Public Law No. 14-84, as amended by Public Laws Nos. 14-96, 14-103, 14-108, 15-13, 15-37, 15-42, 15-53, 16-8, 16-44, 17-17 and 17-61, by amending section 9 thereof, to change the allottee and lapse date of certain funds previously appropriated to fund public projects and social programs in the States of Chuuk, Kosrae, Pohnpei and Yap; and for other purposes.


1 Section 1. Section 9 of Public Law No. 14-84, as amended
2 by Public Laws Nos. 14-96, 15-13, 15-53, 16-8, 16-44, 17-17 and
3 17-61, is hereby further amended to read as follows:

4 "Section 9. All funds appropriated by this act shall
5 be allotted, managed, administered, and accounted for
6 in accordance with applicable law, including, but not
7 limited to, the Financial Management Act of 1979.

8 The allottee of the funds appropriated in Section 1
9 of this Act shall be the President of the Federated
10 States of Micronesia or the President's designee,
11 PROVIDED THAT the allottee of funds appropriated in
12 subsection (1) (f) of Section 1 of this Act shall be
13 the Governor of the State of Kosrae. The allottee of
14 the funds appropriated in Sections 2 and 3 of this
15 Act shall be the Governor of Chuuk State or his
16 designee. The allottee of funds appropriated in
17 Section 4 of this Act shall be the Governor of Yap
18 State. The allottee shall be responsible for

Section 2. This act shall become law upon approval by the President of the Federated States of Micronesia or upon its becoming law without such approval.
