
Dear Speaker Halbert:

I transmit the following Congressional Act, which I signed to become Public Law No. 18-92:

Congressional Act No. 18-101, entitled: "AN ACT TO APPROPRIATE \$555,556 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2015, FOR AIP MATCHING FUND FOR THE STATE OF CHUUK, AND FOR OTHER PURPOSES."

As indicated in its title, the Act appropriates the matching fund for the AIP projects in Chuuk. I thank Congress for finally responding to my repeated requests for matching fund. I proposed such fund in the FY2013 Budget and reiterated it later in the fiscal year session of Congress but was not approved. Although Congress approved \$327,222 in FY2014, it failed to do so in FY2015 notwithstanding the request made by the Executive.





PUBLIC LAW No. 18- 92

---

AN ACT

To appropriate \$555,556 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2015, for AIP Matching Fund for the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. The sum of \$555,556, is hereby appropriated from  
2 the General Fund of the Federated States of Micronesia for the  
3 fiscal year ending September 30, 2015, for the purpose of AIP  
4 Matching for the State of Chuuk.

5       Section 2. Allotment and management of funds and lapse date.  
6 All funds appropriated by this act shall be allotted, managed,  
7 administered and accounted for in accordance with applicable  
8 laws, including, but not limited to, the Financial Management Act  
9 of 1979. The allottee shall be responsible for ensuring that  
10 these funds, or so much thereof as may be necessary, are used  
11 solely for the purpose specified in this act, and that no  
12 obligations are incurred in excess of the sum appropriated. The  
13 allottee of the funds appropriated under this act shall be the  
14 President of the Federated States of Micronesia or his designee.  
15 These funds shall not expire until the funds are expended, or the  
16 grant expires or is terminated, whichever is earlier.
