I am returning the following Congressional Act, which I have signed to become Public Law No. 18-101.

Congressional Act No. 18-105, entitled: "AN ACT TO APPROPRIATE THE SUM OF \$25,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2015, FOR THE PURPOSE OF PROVIDING EMERGENCY SUPPORT TO DEFRAY HUMANITARIAN ASSISTANCE COSTS OF THE EMERGENT HUMANITARIAN SITUATION IN YAP STATE, AND FOR OTHER PURPOSES."

I thank Congress for passing this emergency support act for the State of Yap based upon the recent events leading to 91 persons, at least 36 of which are undocumented, needing humanitarian assistance including food, water, and medical attention, while their legal status is being determined. This experience, and how it is handled, will shape the methods in which similar situations are handled in the future of this Nation. CONGRESSIONAL BILL NO. 18-242, C.D.1

PHRICIAW NO. 18-101

AN ACT

To appropriate the sum of \$25,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2015, for the purpose of providing emergency support to defray humanitarian assistance costs of the emergent humanitarian situation in Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$25,000 is hereby appropriated from
- 2 the General Fund of the Federated States of Micronesia for
- 3 fiscal year ending September 30, 2015, to Yap State for the
- 4 purpose of providing humanitarian support to defray costs of
- 5 essential provisions for undocumented passengers and crew of
- 6 foreign vessels docked in Colonia, Yap State, who are under
- 7 investigation as possible refugees from foreign nations, for
- 8 the period until their repatriation or onward travel may be
- 9 authorized;
- 10 Section 2. These funds are to be used for the costs of
- 11 food, water, shelter, clothing, personal hygiene, and essential
- 12 medical care, and assistance for the passengers and crew
- 13 members of the vessels who are without their own means;
- 14 Section 3. Allotment and management of funds and lapse
- 15 date. All funds appropriated by this act shall be allotted,
- 16 managed, administered and accounted for in accordance with
- 17 applicable laws, including, but not limited to, the Financial
- 18 Management Act of 1979. The allottee shall be responsible for

1	ensuring that these funds, or so much thereof as may be
2	necessary, are used solely for the purpose specified in this
3	act, and that no obligations are incurred in excess of the sum
4	appropriated. The allottee of the funds appropriated under
5	this act shall be the Governor of Yap State. The authority of
6	the allottee to obligate funds appropriated by this act shall
7	lapse on September 30, 2015.
8	Section 4. This act shall become law upon approval by the
9	President of the Federated States of Micronesia or upon its
LO	becoming law without such approval.
