
Dear Speaker Simina:

AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51 and 19-56, by amending sections 3 and 5 thereof, to change the use of funds previously appropriated therein, for the purpose of funding public projects and social programs in the states of Kosrae and Chuuk, and for other purposes.
