AN ACT

To amend Public Law No. 18-11, as amended by Public Laws Nos. 18-44, 18-81 and 19-33, by amending section 2 thereof, to change the lapse date of funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 18-11, as amended

2 by Public Laws Nos. 18-44, 18-81 and 19-33, is hereby further

"Section 2. Allotment and management of funds and lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not limited to, the Financial Management Act of 1979. allottee shall be responsible for ensuring that these funds, or so much thereof as may be necessary, are used solely for the purpose specified in this act, and that no obligations are incurred in excess of the sum The allottee of the funds appropriated appropriated. under subsection 1 of section 1 of this act shall be the President of the Federated States of Micronesia. allottee of funds appropriated under subsection 2 of section 1 of this act shall be the Governor of the State of Yap or his designee. The authority of the allottee to obligate funds appropriated by this act shall lapse
