AN ACT

To appropriate the sum of \$3,330,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2016, for the purpose of funding the contract for the Project Management Unit and education for the dual citizenship referendum, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 2 be necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending
- 4 September 30, 2017, for the purpose of funding the contract for
- 5 the Project Management Unit and education for the dual citizenship
- 6 referendum. The funds appropriated under this section shall be
 - 7 apportioned as follows:

8	(a) PMU additional transition funding \$	450,000
9	(b) Education for the dual citizen referendum .	300,000
10	(c) Yap Preparation for Micro Games	200,000
11	(d) FSM Trust Fund	2,260,000
12	(e) Public hearing trips	70,000
13	(f) Additional funding for IPU trips	50,000

- 14 Section 2. Allotment and management of funds and lapse date.
- 15 All funds appropriated by this act shall be allotted, managed,
- 16 administered and accounted for in accordance with applicable laws,
- 17 including, but not limited to, the Financial Management Act of
- 18 1979. The allottee shall be responsible for ensuring that these

1	funds, or so much thereof as may be necessary, are used solely for
2	the purpose specified in this act, and that no obligations are
3	incurred in excess of the sum appropriated. The allottee of the
4	funds appropriated under section 1 of this act shall be the
5	President of the Federated States of Micronesia or his designee;
6	PROVIDED THAT, the allottee for section 1(c) is the Governor of
7	Yap; the allottee of subsections 1(e) and (f) is the Speaker of
8	Congress. The authority of the allottee to obligate funds
9	appropriated by this act shall lapse on September 30, 2017; EXCEPT
10	THAT funding under subsection 1(d) for the FSM Trust fund shall
11	not lapse.
12	Section 3. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
