

SIXTH SPECIAL SESSION, 2016

CONGRESSIIIONAL BILL NO. 19-228

AN ACT

To further amend Public Law No. 19-10, as amended by Public Laws Nos. 19-26, 19-42, 19-51, 19-56, 19-72, 19-78 and 19-96, by amending section 6 thereof, to change the allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 19-10, as amended by
2 Public Laws Nos. 19-26, 19-42, 19-51 and 19-78, is hereby further
3 amended to read as follows:

4 "Section 6. Allotment and management of funds and
5 lapse date. All funds appropriated by this act shall
6 be allotted, managed, administered and accounted for
7 in accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are
11 used solely for the purpose specified in this act, and
12 that no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of
15 Yap State; PROVIDED THAT, the allottee of funds
16 appropriated under subsection 2(h) of this act shall
17 be the President of COM-FSM. The allottee of funds
18 appropriated under sections 3 and 4 of this act shall

1 be the President of the Federated States of Micronesia
2 or his designee; PROVIDED THAT, the allottee of funds
3 appropriated under subsections 3(a), (b), (c), (d),
4 (e), (f), (g), (h), 9(i), (j) and (k) of this act
5 shall be the Mayor of Lelu Town Government; the
6 allottee of funds appropriated under subsections
7 4(2)(g) and 4(2)(h) shall be the Secretary of the
8 Department of Transportation, Communications and
9 Infrastructure; the allottee of funds appropriated
10 under subsections 4(3)(a), 4(3)(b) and 4(3)(d) of this
11 act shall be the Pohnpei Transportation Authority; and
12 the allottee of funds appropriated under subsections
13 4(3)(f) and 4(3)(h) of this act shall be the Pohnpei
14 Utility Corporation. The allottee of funds
15 appropriated under subsections 5(1), 5(3) and 5(6) of
16 this act shall be the Governor of Chuuk State or his
17 designee. The allottee of funds appropriated under
18 subsection 5(2) of this act shall be the Mortlock
19 Islands Development Authority. The allottee of funds
20 appropriated under subsection 5(4) of this act shall
21 be the Southern Namoneas Development Authority. The
22 allottee of funds appropriated under subsection 5(5)
23 of this act shall be the Faichuk Development
24 Authority. The authority of the allottee to obligate
25 funds appropriated by this act shall lapse on

1 September 30, 2017."

2 Section 2. This act shall become law upon approval by the
3 President of the Federated States of Micronesia or upon its
4 becoming law without such approval.


