

PUBLIC LAW No. 19-133

AN ACT

To amend Public Law No. 19-124, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding priority infrastructure projects in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-124 is hereby

19	Section 2. Section 6 of Public Law No. 19-124 is hereby	
20	amended to read as follows:	
21	"Section 6. Allotment and management of funds and lapse	
22	date. All funds appropriated by this act shall be	
23	allotted, managed, administered and accounted for in	
24	accordance with applicable laws, including, but not	
25	limited to, the Financial Management Act of 1979. The	

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purpose specified in this act, and that
4 no obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of the
7 State of Yap or his designee. The allottee of the funds
8 appropriated under sections 3 and 4 of this act shall be
9 the President of the Federated States of Micronesia or
10 his designee; PROVIDED THAT, the allottee of funds
11 appropriated under subsections 4(1)(c) through 4(1)(o),
12 4(2)(f), 4(3)(c), 4(3)(d), 4(3)(e), 4(3)(g), 4(3)(k) and
13 4(3)(q), 4(3)(s), 4(4)(b), 4(4)(d), 4(4)(f), shall be
14 the Pohnpei Transportation Authority (PTA); the allottee
15 of funds appropriated under subsections 4(1)(b),
16 4(2)(a), 4(2)(c), 4(2)(d) and 4(2)(e) shall be the Mayor
17 of Kolonia Town Government; the allottee of funds
18 appropriated under subsections 4(1)(a), 4(2)(b),
19 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j) and 5(1)(c) shall be
20 the Secretary of the Department of Transportation,
21 Communications and Infrastructure or his designee; the
22 allottee of funds appropriated under subsections
23 (4)(3)(i), 4(3)(o) and 4(3)(r) shall be the Pohnpei
24 Utility Corporation (PUC), the allottee of funds
25 appropriated under subsection 4(3)(j) shall be the

1 Lukenmenlap of Kittiti. The allottee of the funds
2 appropriated under section 5 of this act shall be the
3 Governor of Chuuk State or his designee. The authority
4 of the allottee to obligate funds appropriated by this
5 act shall lapse on September 30, 2017.

6 Section 3. This act shall become law upon approval by the
7 President of the Federated States of Micronesia or upon its
8 becoming law without such approval.


