

CONGRESSIONAL BILL NO. 19-258

#### AN ACT

To further amend Public Law No. 19-60, as amended by Public Laws Nos. 19-71, 19-80 and 19-103, by amending section 2 thereof, to change the use of certain funds previously appropriated therein, for the purpose of funding essential government functions, programs, projects and activities in the state of Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 19-60, as amended by			
2	Public Laws Nos. 19-71 and 19-103, is hereby further amended to
