I hereby return the following congressional act, which was repassed and became Public Law No. 19-154:

Congressional Act No. 19-150: "AN ACT TO AMEND SECTION 219 OF TITLE 55 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA (ANNOTATED), AS AMENDED, TO ALLOW SUB-ALLOTTEES WHO ARE MEMBERS OF CONGRESS TO SUBMIT AN AFFIDAVIT DESCRIBING THE AMOUNT AND NATURE OF AN EXPENDITURE, AS SUFFICIENT EVIDENCE TO SUPPORT A LEGAL OBLIGATION IN THE CASE OF REPRESENTATION EXPENSES AND OFFICIAL EXPENSE ALLOWANCE EXPENSES, WITHOUT REQUIRING SUCH SUB-ALLOTTEES TO PROVIDE OTHER FORMAL APPROVAL SUCH AS A CERTIFICATION BY THE SPEAKER OF CONGRESS, AND FOR OTHER PURPOSES."



(CONGRESSIONAL BILL NO. 19-255)

I hereby certify that on March 28 the foregoing act was repassed by the Nineteenth Congress of the Federated States of Micronesia, Eighth Special Session, 2017, by a threefourths vote of all the State delegations as required under article IX, section 2(q), of the Constitution of the Federated States of Micronesia.

AN ACT

To amend section 219 of title 55 of the Code of the Federated States of Micronesia (Annotated), as amended, to allow sub-allottees who are members of Congress to submit an affidavit describing the amount and nature of an expenditure, as sufficient evidence to support a legal obligation in the case of representation expenses and official expense allowance expenses, without requiring such sub-allottees to provide other formal approval such as a certification by the Speaker of Congress, and for other purposes.
