AN ACT

To amend Public Law No. 19-152, by amending sections 2, 3, 5 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

All funds appropriated by this act shall 6 be allotted, managed, administered and accounted for in accordance with applicable laws, including, but not 7 8 limited to, the Financial Management Act of 1979. 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are used 11 solely for the purpose specified in this act, and that 12 no obligations are incurred in excess of the sum 13 appropriated. The allottee of the funds appropriated under section 2 of this act shall be the Governor of 14 Yap State or his designee. The allottee of funds 15 16 appropriated under sections 3 and 4 of this act shall be the President of the Federated States of Micronesia 17 or his designee, PROVIDED THAT the allottee of funds 18 appropriated under subsections 3(a), 3(b), 3(c), 3(d) 19 20 and 3(e) of this act shall be the Mayor of Lelu Town Government or his designee; the allottee of funds 21 appropriated under subsections 3(f) and 3(g) of this 22 act shall be the Mayor of Tafunsak Municipal Government 23 or his designee; the allottee of funds appropriated 24 under subsections 4(1)(b) and 4(3)(d) of this act shall 25

be the Pohnpei Transportation Authority (PTA); the allottee of funds appropriated under subsections 4(2)(a), 4(2)(b), 4(2)(c) and 4(2)(d) of this act the Secretary of the Department of Transportation, Communications and Infrastructure or his designee. allottee of funds appropriated under subsections 5(1), 5(3), 5(4)(a) and 5(6) of this act shall be the Governor of Chuuk State or his designee. The allottee of funds appropriated under subsection 5(2) of this act shall be the Mortlock Islands Development Authority. The allottee of funds appropriated under subsection 5(4) of this act shall be the Southern Namoneas Development Authority or its designee. The allottee of funds appropriated under subsection 5(5) of this act shall be the Faichuk Development Authority or its designee. The authority of the allottee to obligate funds appropriated by this act shall lapse on September 30, 2018.
