

AN ACT

To appropriate the sum of \$522,000 from the General Fund of the Federated States of Micronesia for the executive branch, national judiciary, Public Auditor and other programs of the National Government of the Federated States of Micronesia for Fiscal Year 1981, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$522,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the executive branch, national judiciary, Public
4 Auditor and other programs of the National Government of the Federated
5 States of Micronesia for Fiscal Year 1981. The sum appropriated by this
6 act shall be apportioned as follows:

20 Section 2. The sums appropriated by this act shall be administered
21 in accordance with the provisions of applicable law, including, but not
22 limited to the Financial Management Act of 1979. The President or his
23 designated allottee may reallocate up to 10 percent of line items in Subsection
24 (1) and in Subsection (4) of Section 1 of this act. The authority to
25 obligate the funds appropriated by this act shall lapse as of

1 September 30, 1981.

2 Section 3. This act shall become law upon approval by the President
3 of the Federated States of Micronesia, or upon its becoming law without
4 such approval.


