

AN ACT

To appropriate the sum of \$636,300 from the General Fund of the Federated States of Micronesia for the Fiscal Year ending September 30, 1981, for the purpose of funding certain public projects in the State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$636,300 or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the Federated
3 States of Micronesia for the Fiscal Year ending September 30, 1981, for
4 the purpose of funding certain public projects in the State of Truk.
5 The sum appropriated shall be apportioned in the following manner:

15 Section 2. All funds appropriated by this act shall be allotted,
16 managed, administered and accounted for in accordance with applicable law,
17 including, but not limited to, the Financial Management Act of 1979. The
18 allottee shall be responsible for ensuring that these funds, or so much
19 thereof as may be necessary, are used solely for the purposes specified
20 in this act, and that no obligations are incurred in excess of the sum
21 appropriated. The funds apportioned by paragraphs (g), (h), (i), (j) of
22 Subsection (5) and Paragraph (e) of Subsection (6) shall not be obligated
23 until the relevant municipal government has submitted a document
24 identifying specific projects and the amounts required therefor, such
25 document reflecting the determinations of the chief magistrate and

1 municipal council of the relevant municipality as indicated by the
2 signature of the chief magistrate. The authority of the allottee to
3 obligate funds appropriated by this act shall lapse as of
4 September 30, 1982.

5 Section 3. This act shall become law upon approval by the President
6 of the Federated States of Micronesia, or upon its becoming law without
7 such approval.
