CONGRESSIONAL BILL NO. 1-139

AN ACT

To appropriate the sum of \$10,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1980, for the purpose of providing surveillance and enforcement capabilities to the Micronesian Maritime Authority within the Extended Fishery Some of the Federated States of Micronesia, and for other purposes.

HE IT ENACTED BY THE CONGRESS OF THE PEDERATED STATES OF MICROMESIA:

- l Section 1. The sum of \$10,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the Federated
- 3 States of Micronesia for the fiscal year ending September 30, 1980 for the
- 4 purpose of providing surveillance and enforcement capabilities to the Micro-
- 5 nesian Maritime Authority within the Extended Fishery Sone, and to match
- 6 a like amount to be provided by the High Commissioner.
- 7 Section 2. The sum appropriated by this act shall be allotted by the
- 8 Director of Finance to the President of the Federated States of Micronesia
- 9 who shall be responsible for ensuring that these funds are used only for
- 10 the purposes specified in this act, and that no obligations are incurred
- li in excess of the sum appropriated. Any part of this appropriation not
- 12 obligated as of September 30, 1980 shall revert to the General Fund of the
- 13 Federated States of Micronesia, or its successor.
- 14 Section 3. The President shall submit a detailed report to the
- 15 Congress of the Federated States of Micronesia before May 1, 1980, which
- 16 shall:
- 17 (1) provide for the full accounting by object class of the
- 18 obligations incurred against the sum appropriated by this act, including
- 19 justification for any significant deviations from line items, and indicate
- 20 the status of these funds as of March 31, 1980;
- 21 (2) indicate the planned use, during the final helf of Fiscal
- 22 Year 1980, of funds not obligated as of March 31, 1980; and
