CONGRESSIONAL RESOLUTION NO. 1-41

A RESOLUTION

Relating to a moratorium on naturalization in the Trust Territory.

- 1 WHEREAS, Article 7 of the United Nations Trusteeship Agreement for
- 2 the Trust Territory of the Pacific Islands provides that the administering
- 3 authority shall guarantee to the inhabitants of the Trust Territory freedom
- 4 of migration and movement; and
- 5 WHEREAS, Secretarial Orders No. 2918, as amended, and No. 3039 provide
- 6 that no legislation in the Trust Territory may be inconsistent with Section
- 7 8 of Title 1 of the Trust Territory Code, which guarantees the inhabitants
- 8 of the Trust Territory freedom of migration and movement within the Trust
- 9 Territory, subject only to the requirements of public order and security;
- 10 and
- 11 WHEREAS, until termination of the Trusteeship Agreement, citizens of
- 12 the Federated States of Micronesia, the Marshall Islands, and Palau will
- 13 be accorded freedom of migration and movement within the Trust Territory
- 14 according to Article 7 of the Trusteeship Agreement and Section 8 of Title
- 15 1 of the Trust Territory Code as incorporated into Secretarial Orders
- 16 No. 2918, as amended, and No. 3039; and
- WHEREAS, the repeal of Section 2 of Article 53 of the Trust Territory
- 18 Code, on naturalization for Trust Territory citizenship, by the legislative
- 19 bodies of the Federated States of Micronsia, the Marshall Islands, and
- 20 Palau, accompanied by a moratorium on enacting new naturalization statutes
- 21 for the Federated States of Micronesia, the Marshall Islands, and Palau
- 22 until termination of the Trusteeship Agreement, would promote a smooth and

1 orderly transition to citizenship under the constitutions and statutes 2 of the Federated States of Micronesia, the Marshall Islands, and Palau; 3 and WHEREAS, the enactment of naturalization statutes by the Federated 5 States of Micronesia, the Marshall Islands, and Palau and the continuation 6 in effect of Section 2 of Article 53 of the Trust Territory Code could 7 pose potential problems for the three emerging nations of the Trust Terri-8 tory; now, therefore, BE IT RESOLVED by the First Congress of the Federated States of 10 Micronesia, Second Regular Session, 1979, that the governments of the 11 Marshall Islands and Palau are hereby requested to consider a moratorium 12 on naturalization in the Trust Territory; and 13 BE IT FURTHER RESOLVED that certified copies of this resolution be 14 transmitted to the President of the Marshall Islands, the President of the 15 Federated States of Micronesia, and the Speaker of the Palau Legislature. 16 17 Adopted: October 26, 1979 18 19 20 21 22 23 24 25
