CONGRESSIONAL RESOLUTION NO. 1-43, CD1

A RESOLUTION

Relating to reduction of service by Continental/Air Micronesia in the Federated States of Micronesia.

- 1 WHEREAS, Continental/Air Micronesia is the major air carrier now
- 2 operating in the Federated States of Micronesia; and
- 3 WHEREAS, Continental/Air Micronesia is the only air carrier now linking
- 4 the Federated States of Micronesia to the United States; and
- 5 WHEREAS, residents of the Federated States of Micronesia are highly
- 6 dependent on Continental/Air Micronesia for international transportation and
- 7 transportation within the Federated States; and
- 8 WHEREAS, the residents of the Federated States of Micronesia also rely
- 9 on Continental/Air Micronesia for emergency medical evacuation services and
- 10 for air freight services; and
- 11 WHEREAS. Continental/Air Micronesia, after increasing the number of its
- 12 weekly flights in the Federated States of Micronesia as recently as
- 13 November 1978, has now made major cutbacks in service, especially to and
- 14 from Hawaii; and
- 15 WHEREAS, Continental Airlines has recently extended air service to
- 16 other Pacific regions; and
- 17 WHEREAS, reduction of air service will have a major negative impact on
- 18 the economy of the Federated States of Micronesia and the welfare of its
- 19 people; and
- 20 WHEREAS, in the area of promoting tourism Continental/Air Micronesia's
- 21 reduction of services and over-emphasis of the Tokyo-Saipan tourist trade
- 22 will discourage both American and Japanese tourists from visiting the states

of the Federated States of Micronesia; and WHEREAS, Continental/Air Micronesia failed to consult with the 2 Government of the Federated States of Micronesia prior to its reduction of 3 service and failed further even to notify the Federated States of Micronesia Government of its plans and intentions; and WHEREAS, established Continental/Air Micronesia schedules should not be reduced to enable Continental Airlines to extend its service to other Pacific regions; now, therefore, BE IT RESOLVED by the First Congress of the Federated States of Micro-9 nesia, Second Regular Session, 1979, that Continental/Air Micronesia is 10 urged to restore its air service to and within the Federated States of 11 Micronesia to previous levels; to consult with the Government of the 12 Federated States of Micronesia prior to future schedule changes or fare 13 adjustments; and to redirect its promotion of tourism and its flight 14 15 schedules to encourage tourism in the Federated States of Micronesia; and BE IT FURTHER RESOLVED that the President of the Federated States of 16 Micronesia is requested to explore methods of increasing air service to and 17 within the Federated States of Micronesia, including the possibility of 18 obtaining additional air carriers to serve the needs of Federated States of 19 Micronesia residents; and 20 BE IT FURTHER RESOLVED that certified copies of this resolution be 21 transmitted to Continental/Air Micronesia Operations Headquarters, to the 22 President of the Federated States of Micronesia, and to the Governors and Speakers of State Legislatures of the Federated States of Micronesia. 24
