A RESOLUTION

Respectfully requesting the Secretary of the Interior, the Office of Management and Budget, and the High Commissioner to give favorable consideration to the budget requests from the States of the Federated States of Micronesis and to request supplemental appropriations from the United States Congress.

- 1 WHEREAS, the individual States of the Pederated States of Micronesia
- 2 develop their respective annual budget requests for review by the High
- 3 Commissioner, prior to the preparation of the annual budget request for the
- 4 Trust Territory of the Pacific Islands; and
- 5 HHEREAS, such budges requests are carefully prepared and reviewed
- 6 within each State to ensure that the annual budget request fairly and
- 7 engurately reflects the needs of the people of the State; and
- 8 MEREAS, the budget requests of the States have been the subject of
- 9 extensive cuts and revisions resulting in severe restrictions on providing
- 10 essential services in the States; and
- 11 WHEREAS, it is the sense of the Congress of the Pederated States of
- 12 Micronesia that supplemental appropriations should be sought from the
- 13 United States Congress to alleviate exerating funding deficiencies which
- 14 the States have experienced; now, therefore,
- 15 BE IT RESOLVED by the Pirst Congress of the Pederated States of
- 16 Micronesia, First Regular Session, 1979, that the Secretary of the Interior,
- 17 the Office of Management and Budget, and the High Commissioner be respectfully
- 18 requested to give favorable consideration to the budget requests from the
- 19 States of the Federated States of Micronesia prior to the submission of the
- 20 budget request for the Trust Territory of the Pacific Islands to the United
- 21 States Congress; and
- 22 BE IT FURTHER RESOLVED that the Secretary of Interior be respectfully
