AN ACT

To further amend title 24 of the Code of the Federated States of Micronesia (Annotated), as amended, by renumbering the chapters and sections created by Public Law Nos. 19-167 and 20-102, to correct technical errors, to reserve chapters 12-14, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The purpose of this Act is to correct the
- 2 duplicate use of chapter and section numbers in title 24 created
- 3 by Public Law Nos. 19-167 and 20-102. Public Law No. 19-167
- 4 enacted section number 505; however, that section number was
- 5 already in use under title 24, and is renumbered as section 506 in
- 6 this Act. Public Law No. 20-102 created a new subtitle II under
- 7 title 24 and enacted chapters 1-10 and sections 101-1024
- 8 thereunder; however, those chapter and section numbers were
- 9 already in use under subtitle I of title 24, and are renumbered
- 10 chapters 15-24 and sections 1501-2424 in this Act. Chapters 12-14
- 11 of title 24 are reserved to leave available for future amendments
- 12 to subtitle I, if necessary.
- 13 Section 2. Section 505 of title 24 of the Code of the
- 14 Federated States of Micronesia (Annotated), as enacted by Public
- 15 Law No. 19-167, is hereby renumbered as section 506.
- 16 Section 3. Chapters 1-10 of subtitle II of title 24 of the
- 17 Code of the Federated States of Micronesia (Annotated), as enacted
- 18 by Public Law No. 20-102, are hereby renumbered as chapters 15-24,

2	Section 4. Sections 101-107, 201-223, 301-308, 401-403,
3	501-508, 601-632, 701-712, 801-806, 901-904, and 1001-1024 of
4	title 24 of the Code of the Federated States of Micronesia
5	(Annotated), as enacted by Public Law No. 20-102, are hereby
6	renumbered as sections 1501-1507, 1601-1623, 1701-1708, 1801-1803,
7	1901-1908, 2001-2032, 2107-2112, 2201-2206, 2301-2304, and
8	2401—2424, respectively.
9	Section 5. Chapters 12-14 of title 24 of the Code of the
10	Federated States of Micronesia (Annotated), as amended, are hereby
11	titled "Reserved".
12	Section 6. This act shall become law upon approval by the
13	President of the Federated States of Micronesia or upon its
14	becoming law without such approval.
