A RESOLUTION

Approving and accepting a grant in the amount of \$386,105 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), to fund and support the Tobacco and Diabetes Programs under the Tobacco and Diabetes Collaborative Partnership in the FSM, including all the terms and conditions of the assistance.

1       WHEREAS, on March 03, 2018, the U.S. Department of  
2 Health and Human Services, Centers for Disease Control and  
3 Prevention (CDC), issued the Notice of Award of financial  
4 assistance in the amount of \$386,105 for the Year Five budget  
5 period starting from March 29, 2018, to March 28, 2023; and

6       WHEREAS, the grant is earmarked to support a specific  
7 project entitled: "Improving Health of the People of the  
8 FSM through Program Leadership and Management, Surveillance  
9 and Epidemiology, and Health System", managed by the FSM  
10 Department of Health and Social Affairs' Tobacco and  
11 Diabetes Programs; and

12       WHEREAS, the grant will also fund and assist the FSM  
13 Tobacco and Diabetes Programs' operational costs for  
14 personnel and other necessary funding in the programs'  
15 partnership's efforts to implement the activities and  
16 services under the project; and

17       WHEREAS, section 210 (2) of title 55 of the Code of the  
18 Federated States of Micronesia (Annotated), as amended,



1 requires that for foreign financial assistance to be valid it  
2 must be approved by Congress by resolution; now, therefore,  
3 BE IT RESOLVED by the Twentieth Congress of the  
4 Federated States of Micronesia, Fourth Regular Session, 2018,  
5 that Congress hereby approves and accepts the \$386,105 grant  
6 from the U.S. Department of Health and Human Services,  
7 Centers for Disease Control and Prevention (CDC), to fund the  
8 FSM Tobacco and Diabetes Programs, including all the terms  
9 and conditions thereof; and

10 BE IT FURTHER RESOLVED that certified copies of this  
11 resolution be transmitted to the President of the Federated  
12 States of Micronesia, the Secretary of the Department of  
13 Health and Social Affairs, and the United States Embassy in  
14 Kolonia.


