Congressional Act No. 21-115, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 16-118, AS AMENDED BY PUBLIC LAWS NOS. 16-24, 16-32, 16-39, 16-45, 16-54, 16-67, 17-04, 17-14, 17-26, 17-39, 17-65, 18-27, 18-47, 18-80, 19-13, 19-108, 20-34, 20-109 and 21-26, BY AMENDING SECTION 1 THEREOF, TO CHANGE THE USE OF certain FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECT AND SOCIAL PROGRAMS in the state of Chuuk, AND FOR OTHER PURPOSES".

AN ACT

To further amend Public Law No. 16-18, as amended by Public Laws Nos. 16-24, 16-32, 16-39, 16-45, 16-54, 16-67, 17-04, 17-14, 17-26, 17-39, 17-65, 18-27, 18-47, 18-80, 19-13, 19-108, 20-34, 20-109 and 21-26, by amending section 1 thereof, to change the use of certain funds previously appropriate therein, to fund public project and social programs in the state of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1. Section 1 of Public Law No. 16-18,
2 as amended by Public Laws Nos. 16-24, 16-32, 16-39, 16-45, 16-54,
