CONGRESSIONAL BILL NO. 21-227, C.D.1

AN ACT

To further amend Public Law No. 10-72, as amended by Public Laws Nos. 10-103 and 16-26, by amending section 6 thereof, in order to modify the composition of the board of the Caroline Island Air Corporation by replacing the chief executive officer with the Secretary of the Department of Transportation, Communications and Infrastructure as ex officio board member, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 10-72, as amended by
2 Public Laws Nos. 10-103 and 16-26, is hereby further amended to
3 read as follows:

4 "Section 6. Board of Directors - Composition.

5 The Board shall be composed of five voting members and
6 one ex officio non-voting member. One member of the
7 Board shall be a representative of the National
8 Government, who shall be the Secretary of the Department
9 of Transportation, Communications and Infrastructure, and
10 there shall be one member representing each of the
11 States. All appointments to the Board, on or after the
12 effective date of this Act shall be made by the President
13 of the Federated States of Micronesia with the advice and
14 consent of Congress. The appointment of any State
15 representative to the Board shall be upon the
16 recommendation to the President by the Governor of the
17 pertinent State. The chief financial officer of the

Corporation, shall serve ex officio as a member of the
Board but he or she shall have no rights to vote."

Section 2. This act shall become law upon approval by the
President of the Federated States of Micronesia or upon its
becoming law without such approval.
