CONGRESSIONAL BILL NO. 21-264

AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117 and 21-169, by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 2 of Public Law No. 19-54, as amended by  
2 Public Law No. 21-117, is hereby amended to read as follows:

3               "Section 2. Of the sum of \$4,800,000 appropriated by  
4 this act, \$700,000 is apportioned for public projects  
5 and social programs in the state of Yap.

5 Section 2. This act shall become law upon approval by the  
 6 President of the Federated States of Micronesia or upon its  
 7 becoming law without such approval.
