CONGRESSIONAL BILL NO. 21-328

AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117, 21-169, 21-174 and 21-194 by amending section 2 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 19-54, as amended by
2 Public Laws Nos. 21-117, 21-174, and 21-194 is hereby further
3 amended to read as follows:

4 "Section 2. Of the sum of \$4,800,000 appropriated by
5 this act, \$700,000 is apportioned for public projects
6 and social programs in the state of Yap.
