I transmit herewith the enclosed Congressional Act, which I have signed to become Public Law No. 21-217, with item veto:

Congressional Act No. 21-223, entitled: "AN ACT TO FURTHER AMEND PUBLIC LAW NO. 20-125, AS AMENDED BY PUBLIC LAWS NOS. 20-135, 20-146, 20-157, 20-179, 20-189, 21-06, 21-40, 21-59, 21-89, 21-96, 21-141 AND 21-155, BY AMENDING SECTIONS 3 AND 4 THEREOF, TO CHANGE THE USE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN, TO FUND PUBLIC PROJECTS AND SOCIAL PROGRAMS FOR THE PEOPLE OF THE STATES OF KOSRAE AND POHNPEI, AND FOR OTHER PURPOSES."

I have been advised of a technical error of over-appropriation by \$25,000 under Pohnpei ED#3 section 4(4)(t) project titled "Nan U Community Center Parking Drainage." This new project is added to the act without a corresponding decrease or de-appropriation of any existing projects under Pohnpei ED#3, causing a discrepancy in the total appropriation. I urge Congress to rectify this error as soon as possible. Thank you.

AN ACT

To further amend Public Law No. 20-125, as amended by Public Laws Nos. 20-135, 20-146, 20-157, 20-179, 20-189, 21-06, 21-40, 21-59, 21-89, 21-96, 21-141 and 21-155, by amending sections 3 and 4, thereof, to change the use of certain funds previously appropriated therein, to fund public projects and social programs for the people of the states of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
