AN ACT

To amend Public Law No. 20-95, as amended by Public Laws Nos. 20-173, 21-47 and 21-72, by amending section 5 thereof, to change the use of funds previously appropriated therein, to fund public projects and social programs for the people of Chuuk state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
