A BILL FOR AN ACT

To amend section 137 of title 36 of the Code of the Federated States of Micronesia (Annotated), as enacted by Public Law No. 20-35, by deleting reference to bearer share, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 137 of title 36 of the Code of the 1 2 Federated States of Micronesia (Annotated), as enacted by Public 3 Law No. 20-35, is hereby amended to read as follows: "Section 137. Fractional shares. 4 (1) A corporation may: 5 (a) Issue fractions of a share or pay in money the value of factions of a share; 7 (b) Arrange for disposition of fractional shares 8 9 by the shareholders; or (c) Issue scrip in registered form entitling the 10 holder to receive a full share upon surrendering enough 11 scrip to equal a full share. 12 (2) Each certificate representing scrip must be 13 conspicuously labeled "scrip" and much contain the 14 information required by section 143. 15 (3) The holder of a fractional share is entitled to 16 exercise the rights of a shareholder, including the 17 right to vote, to receive dividends, and to participate 18

in the assets of the corporation upon liquidation.

1	holder of scrip is not entitled to any of these rights
2	unless the scrip provides for them.
3	(4) The board of directors may authorize the
4	issuances of scrip subject to any condition considered
5	desirable, including:
6	(a) That the scrip will become void if not
7	exchange for full shares before a specified date;
8	(b) That the shares for which the scrip is
9	exchangeable may be sold and the proceeds paid to the
10	scrip holders.
11	Section 2. This act shall become law upon approval by the
12	President of the Federated States of Micronesia or upon its
13	becoming law without such approval.
